sentenced to a fine of Rs1,500/-.

Count III: Failing to provide personal protective equipment to employees to prevent risk of

injury. Was sentenced to a fine of Rs1,500/- and cost of Rs200/- for the three

counts.

9th Case: Le Confort Ltee

Count I: Using a building as a lodging accommodation without holding a Lodging

Accommodation Permit issued by the Permanent Secretary of the Ministry of Labour, Industrial Relations, Employment and Training in respect of the building.

Was sentenced to a fine of Rs1,500/- and cost of Rs200/-.
