a fine of Rs15,000/-.

counts.

12th Case: Island Builders Ltd

Count I: Failing to ensure that access is provided from one level of scaffold to another.

Was sentenced to a fine of Rs2.000/-.

Count II: Failing to ensure that a scaffold is effectively braced by means of longitudinal

Count I: Failing to ensure that a scaffold is effectively braced by means of longitudinal

and transverse bracing systems which extend from the base to the top of the

scaffold. Was sentenced to a fine of Rs2,500/-.

Count II: Failing to ensure that any work platform provided does not have any opening

except to allow access to that work platform. Was sentenced to a fine of

Rs2,500/-.

Count III: Failing to ensure that every side of a work platform from which a person is liable

to fall more than 2 metres is provided with 2 or more quardrails. Was sentenced

to a fine of Rs2,500/- and cost of Rs200/- for the three counts.

18th Case: Mauritius Institute of Training and Development

Count I: Requiring employees to work in a place of work in respect of which a fire

certificate was required without such certificate being in force. Was sentenced to

a fine of Rs5,000/- and cost of Rs200/-.

19th Case: The District Council of Pamplemousses

Count I: Failing to ensure the safety and health at work of its employees. Was sentenced

to a fine of Rs8,000/- and cost of Rs200/-.

20th Case: MFM Confection Ltd

Count I: Failing to notify accident. Was sentenced to a fine of Rs2,000/-.

Count II: Failing to send report of accident. Was sentenced to a fine of Rs2,000/- and

cost of Rs200/- for both counts.

21st Case: Gean Doddy

Count I: Failing to notify accident. Was sentenced to a fine of Rs2,000/-.

Count II: Failing to send report of accident. Was sentenced to a fine of Rs2,000/- and

cost of Rs200/- for both counts.

22nd Case: Tradeway International Ltd

Count I: Operating a factory without it being registered. Was sentenced to a fine of

Rs3,000/-.

of Rs200/- for both counts.

23rd Case: Ji Yun Knits Ltd

Count I: Using a building as a lodging accommodation for employees without holding a

Lodging Accommodation Permit. Was sentenced to a fine of Rs2,000/- and cost

of Rs200/-.
