1st Case: Beijing Construction Ltd

Count I: Failing to cause gates of lift to be fitted with interlocking device. Was sentenced to a fine of Rs5,000/- and cost of Rs200/-.

2nd Case: China Jiangsu International Economic-Technical Cooperation Corporation

Count I: Using a building as a lodging accommodation for its employees without holding a Lodging Accommodation Permit issued by the Permanent Secretary of the Ministry of Labour, Industrial Relations, Employment and Training in respect of building. Was sentenced to a fine of Rs5,000/- and cost of Rs200/-.

3rd Case: China Jiangsu International Economic-Technical Cooperation Corporation

Count I: Using a building as a lodging accommodation for its employees without holding a Lodging Accommodation Permit issued by the Permanent Secretary of the Ministry of Labour, Industrial Relations, Employment and Training in respect of building. Was sentenced to a fine of Rs5,000/- and cost of Rs200/-.

4th Case: China Jiangsu International Economic-Technical Cooperation Corporation

Count I: Using a building as a lodging accommodation for its employees without holding a Lodging Accommodation Permit issued by the Permanent Secretary of the Ministry of Labour, Industrial Relations, Employment and Training in respect of building. Was sentenced to a fine of Rs5,000/- and cost of Rs200/-.

5th Case: China Jiangsu International Economic-Technical Cooperation Corporation

Count I: Using a building as a lodging accommodation for its employees without holding a Lodging Accommodation Permit issued by the Permanent Secretary of the Ministry of Labour, Industrial Relations, Employment and Training in respect of building. Was sentenced to a fine of Rs5,000/- and cost of Rs200/-.

6th Case: JNL Agencies Ltd

Count I: Failing to equip the first-aid box so as to contain the appliances and requisites of first-aid set put in the First Schedule. Was sentenced to a fine of Rs2,000/- and cost of Rs200/-.

7th Case: Royal Choice Restaurant Ltd

- Count I: Failing to review a risk assessment not later than 2 years. Was sentenced to a fine of Rs2,000/-.
- Count II: Failing to cause building to have a watertight roof. Was sentenced to a fine of Rs2,000/- and cost of Rs200/- for both counts.

8th Case: S.A.I. Building Civil & Gross Mechanical Engineering Contractors Ltd

Count I: Failing to cause first-aid box to be readily accessible to the employees. Was sentenced to a fine of Rs800/- and cost of Rs200/-.

9th Case: Lemon Construction Co Ltd

Count I: Using a building as a lodging accommodation for its employees without holding a Lodging Accommodation Permit issued by the Permanent Secretary of the Ministry of Labour, Industrial Relations, Employment and Training in respect of building. Was sentenced to a fine of Rs1,000/- and cost of Rs200/-.

10th Case: Rui Le Morne Ltd

- Count I: Failing to notify by quickest practicable means. Was sentenced to a fine of Rs3,000/-.
- Count II: Failing to ensure safety and health of employees. Was sentenced to a fine of Rs5,000/- and cost of Rs200/- for both counts.

11th Case: Rehm Grinaker Construction Co Ltd

Count I: Failing to ensure that the scaffold is effectively braced by means of longitudinal and transverse bracing system which extend from base to top of scaffold. Case dismissed.

12th Case: Building and Civil Engineering Co Ltd

Count I: Using a building as a lodging accommodation for its employees without holding a Lodging Accommodation Permit issued by the Permanent Secretary of the Ministry of Labour, Industrial Relations, Employment and Training in respect of building. Was sentenced to a fine of Rs1,000/- and cost of Rs200/-.

13th Case: Fit Out Mauritius Ltd

Count I: Failing to establish a safety and health committee. Was sentenced to a fine of Rs2,000/- and cost of Rs200/-.

14th Case: Christodesign Co Ltd

- Count I: Using a building as a lodging accommodation for its employees without holding a Lodging Accommodation Permit issued by the Permanent Secretary of the Ministry of Labour, Industrial Relations, Employment and Training in respect of building. Was sentenced to a fine of Rs1,000/- and cost of Rs200/-.
- 15th Case: Quad Ltd
- Count I: Operating a factory without it being registered. Was sentenced to a fine of Rs3,000/-.
- Count II: Failing to make suitable and sufficient assessment of risk to the safety and health to which any employee is exposed whilst at work. Was sentenced to a fine of Rs2,000/- and cost of Rs200/- for both counts.
