1st Case: L. Sofia Bakery & Pastry Ltd

Count I: Operating a factor without it being registered under the Occupational Safety and

Health Act 2005. Was sentenced to a fine of Rs1,500/- and cost of Rs200/-.

2nd Case: Alteo Agri Ltd

3rd Case:

Count I: Failing to forward a written record of proceedings of a Safety and Health

Committee meeting within 10 days of the meeting to the Director, Occupational Safety and Health. Was sentenced to a fine of Rs20,000/- and cost of Rs200/-.

Count I: Failing to ensure the safety, health and welfare at work of its employees. Was

sentenced to a fine of Rs40,000/- and cost of Rs200/-.

4th Case: Oceantex Garments Ltd

Terra Milling Ltd

Count I: Failing to cause steam boiler and all its fittings and attachments to be thoroughly

examined by a Registered Boiler Inspector at least once every 12 months.

Count II: Failing to cause air receiver to be examined at least once every 12 months by a

Registered Machinery Inspector.

Count III: Failing to carry out a fire drill according to an established fire and emergency

plan approved by the Mauritius Fire and Rescue Service at least once a year at

a place of work where a fire certificate has been issued. Was sentenced to a

fine of Rs25,000/- and cost of Rs200/- for the three counts.
