1st Case: Joseph Aurelio Perrine

Count I: Failing to ensure safety, health and welfare of its employees. Was sentenced to

a fine of Rs45,000/- and cost of Rs200/-.

2nd Case: SVP Ltee

Count I: Failing to make a risk assessment in respect of its undertaking. Was sentenced

to a fine of Rs3,000/- and cost of Rs200/-.

3rd Case: Fuel Steam and Power Generation Ltd

Count I: Failing to maintain any place of work under its control, including the means of

access to, or egress from it. Was sentenced to a fine of Rs40,000/- and cost of

Rs200/-.

4th Case: Onix Co Ltd

Count I: Failing to ensure safety and health of its employees. Case was dismissed.

Count II: Failing to cause a lifting machine to be examined by a Registered Machinery

Inspector before being taken into use for the first time in the place of work. Was

sentenced to a fine of Rs5,000/- and cost of Rs500/-.

5th Case: Plastic Industries Ltd

Count I: Failing to ensure, so far as is reasonably practicable, the safety, health and

welfare at work of its employees by having failed to prevent danger by earthing

or suitable means. Was sentenced to a fine of Rs50,000/-.

Count II: Failing to ensure, so far as is reasonably practicable, the safety, health and

welfare at work of its employees by failing to provide suitable means to cut off supply of electrical energy to any electrical equipment. Was sentenced to a fine

of Rs50,000/-.

Count III: Failing to ensure, so far as is reasonably practicable, the safety, health and

welfare at work of its employees by failing to provide residual current device having a rated residual operating current of 30 milliamperes or less. Was

sentenced to a fine of Rs50.000/- and cost of Rs200/- for the three counts.

6th Case: General Construction Ltd

Count I: Failing to cause opening in stairway to be fenced. Was sentenced to a fine of

Rs5,000/- and cost of Rs200/-.

7th Case: Poster Graphics Ltd

Count I: Requiring employees to work in a place of work where a fire certificate is

required without such certificate being in force. Was sentenced to a fine of

Rs4,000/- and cost of Rs200/-.

8th Case: Kuros Const Ltd

Count I: Failing to cause open sides to be fenced. Was sentenced to a fine of Rs3,000/-.

Count II: Failing to cause opening in stairways to be fenced. Was sentenced to a fine of

Rs3,000/- and cost of Rs200/- for both counts.

9th Case: Harold Priory

Count I: Failing to cause open sides to be fenced. Was sentenced to a fine of Rs2,000/-.

Count II: Failing to cause opening in stairway to be fenced. Was sentenced to a fine of

Rs2,000/- and cost of Rs200/- for both counts.

10th Case: Mobilier International Ltd

Count I: Failing to carry out a fire drill. Was sentenced to a fine of Rs2,000/- and cost of

Rs200/-.

11th Case: Intelligently Made Furniture Ltd

Count I: Requiring employees to work in a place of work where a fire certificate is

required without such certificate being in force. Was sentenced to a fine of

Rs2,000/- and cost of Rs200/-.
