Count I: Failing to provide means to prevent a person from falling at a height of 2 meters.

Was sentenced to a fine of Rs2,000/- and cost of Rs200/-.

12th Case: Atchamah Ramoortee

Count I: Failing to ensure that access is provided from one level of scaffold to another.

Was sentenced to a fine of Rs1,500/-.

Count II: Failing to ensure that work platform is boarded. Was sentenced to a fine of

Rs1,500/-.

Count III: Failing to provide guardrails to scaffold platform. Was sentenced to a fine of

Rs1.500/- and cost of Rs200/- for the three counts.

13th Case: Lall Bahadoor Ramkhelawon

Count I: Failing to ensure that scaffold is boarded. Was sentenced to a fine of Rs2,000/-.

Count II: Failing to ensure that scaffold is braced. Was sentenced to a fine of Rs2,000/-.

Count III: Failing to provide guardrails to scaffold platform. Was sentenced to a fine of

Rs2,000/- and cost of Rs200/- for the three counts.
