1st Case: Hi Tech Construction Co Ltd

Count I: Failing to cause open side of the building on the fourth floor to be adequately

fenced. Was sentenced to pay a fine of Rs2,000/- and cost of Rs100/-.

2nd Case: China International Water Electric Corp (Bagatelle)

Count I: Failing to ensure that openings in scaffold from which persons are liable to fall to

be adequately boarded over. Was sentenced to pay a fine of Rs2,000/-.

Count II: Failing to ensure that working platform of scaffold is provided with substantial

guardrails. Was sentenced to pay a fine of Rs2,000/- and cost of Rs200/- for

both counts.

3rd Case: Emcar Limited

Count I: Failing to establish a Safety and Health Committee. Was sentenced to pay a

fine of Rs2,000/- and cost of Rs200/-.

4th Case: Lising & Co Ltd

Count I: Failing to establish a Safety and Health Committee. Was sentenced to pay a

fine of Rs2,000/-.

Count II: Failing to carry out a fire drill at least once a year at its place of work according

to an established fire and emergency plan approved by the Fire Services. Was

sentenced to pay a fine of Rs3,000/- and cost of Rs200/- for both counts.

5th Case: Trait D'Union Ltee

Count I: Failing to make risk assessment. Was sentenced to pay a fine of Rs5,000/-.

Count II: Failing to carry out a fire drill. Was sentenced to pay a fine of Rs2,000/-.

Count III: Failing to notify the Government Fire Services of increase in number of

employees. Was sentenced to pay a fine of Rs2,000/- and cost of Rs200/- for

the three counts.

6th Case: The Finesse Marketing Ltd

Count I: Using a building as a lodging accommodation without holding a Lodging

Accommodation Permit. Was sentenced to pay a fine of Rs2,000/- and cost of

Rs200/-.

7th Case: Original Confection Ltd

Count I: Failing to provide interlocking device to lift. Was sentenced to pay a fine of

Rs4,000/- and cost of Rs200/-.

8th Case: HV Industries Ltd

Count I: Failing to ensure safety and health of employees. Was sentenced to pay a fine

of Rs8,000/- and cost of Rs200/-.

9th Case: Northern Printing Ltd

Count I: Failing to fence machine. Was sentenced to pay a fine of Rs3,000/- and cost of

Rs200/-.
